Water chestnuts or lotuses grow in large numbers in the vallev. Some events can be woven around these themes. Recently, a leading figure of the tourism sector said to me that tourism is not just what is available. Tourism is also created. These are the ways in which tourism can be created.

We often don't attach so much value to our heritage and local cultural traditions, because we do not realize the commercial strength that can accrue from them. Globally, mega tourist events have been woven around local cultural traditions. It is time for us to celebrate our culture and create tourism around these activities. This will protect our local heritage and culture and also popularize them globally.



This problem was faced in some states in India too. The dominant preference for sons led to female infanticide in these states. Today these states are facing a similar set of complications.

Interfering with the universal justice of the Almighty is not correct. We must accept daughters and sons alike. We must remove social evils like dowry. Our education and learning must enable us to make the right choices and the right decisions in life that are high on values and morals.




he statement of J&K Apni Party chief Mr Altaf Bukhari that no person from outside the state will be allowed to settle in Jammu and Kashmir is indicative of the fear and the anger of the common man against the current antiencroachment drive in the union territory.

"Those who are not a citizen of J&K, will not be allowed to settle here. The police and security forces will try their best to settle them, but we will not step back. This is our land and we are its people. We are not wearing bangles," Mr Bukhari said.

This statement has come from the chief of Apni Party. Over the last few years, many in Kashmir have called Apni Party as the B Team of BJP in Jammu and Kashmir.

It is to be noted that Mr Bukhari, who is also a former minister in the erstwhile state, had stated on January 5 that his party would not be averse to forming an alliance with the BJP to form a government in Jammu and Kashmir when the elections were held.



Vital To Keep Faith Of People At Bottom Of Pyramid

In some quarters, it is being felt that the messaging of the anti-encroachment drive has been faulty. Some analysts say that in order to protect their own land-grabbing, the politicians inflamed the voters.

But at the end of the day, what matters is not how the politicians tried to inflame or mislead the voters. What matters is what messaging that the people finally believe.

In this era of post Article 370, the middle class along with the rural and urban poor are the new and firm believers in the state. They have started developing faith and believing in the idea of a virtuous India and a prosperous Kashmir.

The rural and urban middle class and the poor are the ones who have moved forward with the ideas of Naya Bharat and Naya Kashmir. They believe in the government's promise of development. They have given

currency and acceptance to the idea of Naya Kashmir.

If any new policies leave gaps for creation of fears and rumours, it shall hurt the faith of the people at the bottom of the pyramid. People in rural areas have started believing in India. Their faith must not be shaken. Otherwise it can disrupt the peace achieved with so much toil. It can adversely impact the nation-building measures in Kashmir.

It is correct that the fears and anxieties over the antiencroachment drive have been fuelled by the politicians who are trying to protect their own encroachments over prime state land and kahcharai land. At the same time, it was important for the Centre to have sent out the correct messaging regarding the anti-encroachment drive before initiating it.

Correct and constant messaging regarding the antiencroachment drive would have reassured the people and would not have given any space for fears to grow or multiply.

Media Reports Say Policy May Be Announced Soon

On February 13, reports emerged that the Centre is soon coming out with a policy that will protect small land holders from the anti-encroachment drive that is currently in force in the union territory. Reports said that the policy has been given the shape and is expected to be announced shortly.

Lieutenant Governor Manoj Sinha had repeatedly assured the people that small land holders will be spared from the anti-encroachment drive. Sources revealed that the policy has been drafted while addressing this aspect.


Kashmiris who are committed nationalists and are concerned over the emerging situation say that the announcement regarding the policy should have been made beforehand.

In the absence of the policy, confusion and fear has risen to the fore. The announcement of the policy to protect small land-holders from the antiencroachment drive is an effort by the Centre to address these fears. Wherever one goes, whether to a neighbourshood grocery shop, the salon, any common area, the talk relates to the current anti-encroachment drive.

Confusion And Fear Has Risen, Wrong Notions Being Spread

It is important for the government to announce the policy soon that shall reassure those with small land-holdings that they shall not be divested of their property. The people will support the anti-encroachment drive as the correct initiative if it targets only the influential and powerful land grabbers.

At the time of the abrogation of Article 370, the entire political class of J&K was held in detention by the Centre. This had been done as a pre-emptive measure so that no violence could be engineered by the political forces which would disrupt the peace process.

At that time, across the nation people were surprised to learn that Kashmiris were delighted and celebrating that the political class had been kept under detention. Good governance and the transparent policies of the UT Administration have resonated with this class and have reinforced their faith in the state. The middle class and the poor, whether in urban or rural areas, are identifying with the Indian state. It is important for the state to strengthen and reinforce their faith at all times.

Kashmiris who are committed nationalists say that due to lack of the correct messaging, wrong notions are being spread regarding the anti-encroachment drive. They highlight that before formulating any policy, the Central government must bear in mind that Kashmir has been a disturbed area. In this light, for the implementation of any policy, the government

must consider the merits and demerits from all dimensions.

Those who are engaged in building anti-state narratives keep working silently. Any fear or anger among the people gives them space to spread negative sentiment against the state. It is important that no space is provided to the terror ecosystem to spread rumours and disinformation regarding the state.


If People's Faith Is Shaken, It Can Weaken Gains Made By The Government



At ground level, those who stand with the state are working hard to build a positive narrative. The game in Kashmir is largely based on perception. It is important that the initiatives of the government are seen in the right perspective.

India must empower, uplift, and give more representation to the poor. Those at the helm of power must always be cognizant of the fact that if the rural and urban poor and the middle class are agitated, it has the potential to dilute Prime Minister Mr Narendra Modi's Idea of "Naya Kashmir".

Regarding the antiencroachment drive, fear and anxiety have sparked off rumours among the people. At many places, people have started protesting, organizing demonstrations and blocking roads to show their resentment against the land encroachment drive. The bottom-line remains that if there are problems in the implementation of any policy at ground level, it can lead to disillusionment, despair, and resentment.





he varying response of the implementation agencies at ground level to blatant cases of encroachment has led to confusion among the people. At some places, the encroachment has been demolished by bulldozers. At other places, the buildings made over encroached land have been sealed. At even more places, violations of a similar nature have been overlooked or deliberately ignored.


All this confusion could have been avoided if the government

had announced the J&K Anti Encroachment Land Retrieval Policy before initiating the exercise at ground level. The policy must specify what kind and what size of buildings shall be sealed or demolished. What are the kinds of structures and up to what size that shall be categorized as "small-holder property" and shall be spared from the anti-encroachment drive.

If this exercise had been initiated beforehand, the anti-state forces would not have been able to spike fears and anxiousness among the commoners.



among the small land-holders

The reason is that this fear has deliberately been manufactured by our politicians. From the beginning, the LG Administration had specified that the target of the antiencroachment drive shall be those influential persons who misused their power, privileges and connections to illegally grab state land and construct different types of structures on them – both residential and commercial.

The government knows that the people would have appreciated the move to retrieve state land from the influential encroachers and land sharks. At the same time, the politicians know that they shall not be able to justify their blatant land grabbing. That is why they have raised the bogey of people's exploitation in the anti-encroachment drive.

Within the first few months after the abrogation of Article 370, the people themselves observed a marked change in our society. In private conversations, we started admitting that the people of Kashmir are pragmatic. They have moved on after the abrogation. What they seek

is peace and progress, and a stable future for their children.

Our politicians cannot digest this new reality. They keep taking people up the garden path, telling them that Article 370 shall be restored. But people are smart. They know the truth, and they know how to adapt to the truth.

It is only our politicians who continue to make Article 370 a big issue. They continue to flog the dead horse, doing politics over its abrogation or restoration.

DEMOLITION OF HUGE COMMERCIAL STRUCTURE ON STATE LAND IN JAMMU

In conversations, many people question why did the Administration have to break down commercial structures at some places? They could have attached it.

I believe that the action that was initiated was absolutely correct. We need to remember that the right message has been delivered to the politically powerful and the influential that they cannot take the state for a ride.

All over India, rich and influential men are not allowed to grab prime state land and build personal structures. If this is done, the state shall have no authority, and it shall be a freefor-all. Pakistan allowed the rich and influential to do what they wanted, and look where Pakistan is today. People don't have roti, they don't have petrol, and Pakistan is begging the world for money.

Small-Holders Have Not Been Targeted

The same is the case with the manufactured opposition among the people over the antiencroachment drive. The truth is that the Administration has not targeted the small-holders during the anti-encroachment drive. Land is being retrieved only from those who have indulged in huge land-grabbing or have taken on the role of land sharks.

We all know what our politicians have done in Kashmir in the name of the conflict. State land, Kahcharai land – all this was grabbed and colonized in the most posh areas. A number of our political leaders have been in the business of property dealing through their proxies. For years, they have indulged in the dalali of prime land and have made crores upon crores in profit.

What was the pattern of the politicians in Kashmir? Five marla milkiyat land, 15 marla state land – put it together and raise a residential structure, a commercial structure. That is why they are instigating the people for ho-halla. They are inflaming the poor by saying that you all are going to lose your land.

Rumours Have Been Deliberately Manufactured, Circulated

In the peripheral areas of Jammu where the antiencroachment drive was carried out, no one owning a few marlas was disturbed. But still there was stone-pelting in the area.

Powerful politicians from different political parties or their relatives own lavish personal and commercial structures in the peripheral areas of Jammu. These leaders have extensive land ownership here. The stone pelting took place in the area. What is the correlation?

Rumours have deliberately been floated in Kashmir. Fears have been created. Slowly, truth will be revealed before the people. Our politicians cannot fool all the people all the time.

The politicians know that if the drive continues, they will get exposed before the public. The land grabbed by them shall be retrieved. That is why they instigate the common people that small-holders shall lose their land. They want to bring the people on the road to save themselves.



e know that our entire political class is fragmented.

They came together for PAGD. That fell apart soon enough. So what is the reason that they are all united against the antiencroachment drive?

The reason is that they know that their corruption and nepotism shall be exposed. They have occupied land in posh areas themselves, in the name of their relatives. That is why our politicians are afraid of being



caught. They also know that if the people come on the roads to protest the drive, they will not lose their illegally occupied land.



Wrong To Give Communal Angle

I see that some people are giving a communal angle to the anti-encroachment drive. This is not the truth. The government should carry out the drive even with greater force than before so that people are able to see how the political royals were making fools of us.

In the posh areas in which our politicians own land in Srinagar, Jammu and other major towns of Kashmir, the land must be measured. How much of it is state land, how much is milkiyat land. We are talking about areas where a kanal sells for crores.

In siyasat daano ne zannat ko loot kar khaya hai. They and their cliques have looted ecologically sensitive zones like Gulmarg, Pahalgam. They or their cohorts were always in the forefront for land grabbing.

LAND SHARKS: POLITICIANS, THEIR RELATIVES, RETIRED BUREAUCRATS

Official figures reveal that nearly 4 lakh kanal of encroached State and Kahcharai land has been retrieved encroachers in J&K UT. These are mostly politicians, their relatives and retired bureaucrats across Kashmir valley. The Administration has further specified that the drive will continue without any break till the remaining 2.74 lakh kanals of land is taken back from the grabbers.

Official figures reveal that 2,16,683 kanals of state land has been retrieved from encroachers in 10 districts of Kashmir valley till date. Most of the owners are influential persons who had misused their power to construct residential or commercial structures on the grabbed state or Kahcharai land.

Some top bureaucrats are also involved in this racket of grabbing state land. All these rich and influential people know that legally, they cannot question the government's move. So they are using the people as a convenient front.

They can make any kind of content trend or go viral. They are using social media as a tool to deepen fear among the poor regarding the antiencroachment drive.

The DCs should interact with them, involve them in the local initiatives. Social media is a huge space. The government must proactively engage the influencers in this space.

Many social media influencers keep posting negative stuff because nobody has explained the right perspective to them. Engaging with them can set off a cycle of positive communication on both sides.

remain a dirty job. Let me explain
why.

Ms Sherwani, you are among those who are preparing the ground for more innocent, gullible Kashmiri youth to pick up arms against the state and join terror groups like The Resistance Front, Hizbul Mujahideen, Jaish e Mohammad and others. Or they shall become Over Ground Workers (OGWs) for terror groups, providing support for all activities. Or they shall become hybrid militants.

You, of course, may have considered none of this. You think that you are doing "honest journalism" by giving voice to the feelings of the people. No Ms Sherwani. Your work is far more insidious. You are practicing narrative terrorism.

Does it matter to you that a section of Kashmiri youth

continue to choose violence to kill and die, and one of the reasons is the intellectual deceit of people like you? Does it matter to you that these budding youth leave their parents and siblings wailing and distraught, and injured for life?

I should know what I am talking about, Ms Sherwani. I was among those youth who got entrenched in the terror ecosystem. Many factors in Kashmir contributed to that entrenchment. One of the factors was the relentless bashing of the government by "honest journalists" like you.

Fools that we were, boys like me put two and two together and made ten. When we read news reports like yours, they were validation for us that Pakistan's propaganda was right. We believed your bashing of the Indian government. This bashing justified the Pakistan narrative on Kashmir. It made Pakistan's narrative look honest. It made us believe that the separatists were right.

Ms Sherwani, I was a hardworking student who was studying to be a doctor. In Class 12, I got carried away by the separatist ideology and became a hard-core stone thrower, relishing the mindless clashes with the security forces in my hometown.

Steadily, I became an Over Ground Worker (OGW) for Hizbul Mujahideen, the militant arm of the Jamaat e Islami – the fountainhead for the toxic separatist narrative in Kashmir. I used to be the gang leader for organized groups of stonepelters. I was so aggressive that in my area, people used to call me "Chhota Geelani". I was jailed thrice for my violent ways.

My life transformed when I realized in jail that poor boys like me were being fooled so that we became terrorists and OGWs, while the separatists and their children were flourishing in luxury. Ms Sherwani, my father couldn't bear the pain of seeing his son's life destroyed, in and out of jail. Vo merey ghum me mar gaya.

How do you fit into this story, Ms Sherwani? You fit in because of the ideology you practice. You were in Kashmir some days ago, releasing one video report after another.



Please note, Ms Sherwani, that the abrogation of Article 370 is steadily ending the duplicity in Kashmir. It has put an end to the engineered deaths on our streets, the grievous pellet injuries for our youth, the never-ending hartal calendar, the shutdown of educational institutions for months together, the local economy in doldrums

You consistently projected the abrogation of Article 370 as deep damage done to Kashmir and to Kashmiris.

Ms Sherwani, I say to you with humility and gentleness – please stick to your comfortable,

plush life in Delhi. Don't tell us Kashmiris that abrogation is the worst thing that happened to us.

Terror forces have been assiduously working in Kashmir for decades to radicalize and indoctrinate gullible youth. Your propaganda will deepen their manufactured alienation. It will fuel the carefully planted angst inside a section of our youth against the Indian state, and they may choose the path of violence and terror. This shall derail our hard-earned peace and progress.

Or if you want to come to Kashmir, Ms Sherwani, please be honest to your God and to your profession. Please take note of the sweeping positive changes that we are witnessing at ground level after the abrogation of Article 370.

Your video series reveals your seething anger over the abolition. You declare in your "honest journalism" video that the voluble Kashmiri has been forced into silence by the government. Are you aware, Ms Sherwani, that the

terror ecosystem allowed the voluble Kashmiri only to lambast the government? He was not allowed to ever question the terror ecosystem. Hundreds of Kashmiris who dared to defy the terror players were brutally killed.

Ms Sherwani, I still live in Old Town Baramulla, my home town, which used to be called mini Pakistan. For years now, I have counselled scores of boys who were on the brink of joining terror ranks. Their parents or other family members reach out to me in despair to protect their sons. I give these youth my own example and tell them not to destroy their life, their career.

Ms Sherwani, read the recent comment of former Congress leader Mr Ghulam Nabi Azad. He said, "Anger against Centre (over abrogation of Article 370 and 35A) was slightly cooling down, militancy was ending, people could freely roam outside, strikes & stone-pelting ended..."


Need To Ensure That No Officer Is Acting With Mala Fide Intention

The government is concerned to safeguard the interests of poor people".

Despite this, fears continue to besiege the general populace, generating rumours and disinformation. It needs to be carefully watched that no government functionary is able to act with mala fide intention to target the poor with the intention to malign the state.



The Messaging Of Any Initiative Is Very Important

The district administrations across the Union Territory need to be wary. The positive intentions of the antiencroachment drive shall be compromised if some officer driven by mala fide agenda deliberately targets the small-holders.

The Administration must assiduously follow what was known as Macaulay's Downward Filtration Theory For Education. The British educated some upper caste Indians so that the move would influence the lower
