ow many times we have heard this. Said over and over again, perhaps to teach all girls to suffer domestic violence without questioning or protesting it. Bardasht karna padhta hai.

Just last week, a young woman two years senior to me in college came to her parents house, beaten by her motherin-law and her nanand. There were bruises on her face and her body. There were injuries caused by nails on her face. All of us who know her were aghast to see her.

#### No Excuse Is Acceptable

No excuse for domestic violence is acceptable. It is a crime that women are taught to ignore. Domestic violence is deeply entrenched in our society for ages. It is characterized by the violent behavior inflicted to assert dominance over the partner or any other family member. Often, the victims of this violence are women. It is not a stray or one-off incident. It is repetitive and follows a pattern of intimidation and suppression.

In the valley, innumerable women are subjected to different forms of abuse from their spouse or their in-laws within four walls. Sexual or physical abuse by the spouse, psychological or physical abuse by the in-laws – we hear of all these from time to time. Women belonging to all classes, sects, ages and caste are subjected to extensive barbarism in their households.

Women are being exposed to an environment that teaches them to uncomplainingly accept the abuse and pretend to be happy and satisfied, suppress their ambitions and prioritize every other thing over themselves. This toxic traditional indoctrination is making women vulnerable to exploitation.

#### I Was 14 When I First Heard Of Domestic Violence

I was 14 when I first heard about the case of a woman being hanged by her In-laws in her own house. It wrenched my heart and was enough to disturb

the frame of my mind for a long period. After a month or two, the incident was beautifully presented to society that she was not killed. She committed suicide, leaving her innocent children behind.

Cases of a woman burnt to death by her husband. Killed by her devar because she resisted his sexual advances. Beaten by her husband on a frequent basis for no apparent reason. Beaten by her mother-in-law, her nanand - one heard of such cases all too often.

I grew up to be 22 years

old listening to such incidents year after year. Women beaten, insulted, cheated on, killed, assaulted, abused by a close friend, or by in-laws, siblings. An extreme pain runs within my veins when I think of women who are not safe in their own families, in their own homes. The pain has provoked me to write. It amazes me when I my fellow Kashmiris – a Valley known for its warmth and hospitality - turn a blind eye easily to the pain of their daughters, their sisters, their better halves.



#### How The Society Normalizes Domestic Violence

There are these standard sentences we hear.

"Yeh to hota rehta hai." This happens.

"Sasural to aisa he hota hai beta." Inlaws are like this only, dear daughter.

"Yeh unka apas ka masla hai." It is their private affair.

"Mard maaf nahi karte." Men don't spare.

"Ab jo hai, jaisa hai, wohi tumhara ghar hai." Now whatever it is, however it is, it is your only home.

All these are the nourishing factors for male dominance in society.

#### The Pattern Of Blaming The Girl

Often I used to hear incidents of domestic violence from my married classmates or neighbours in the last one or two years. I started discussing it among my friends, my relatives. I asked them why it happens and why women are expected to bear.

Different people answered these questions differently because their perspectives are different. Many people told me to stay out of this and not to get affected mentally. Some told me that the girls are at fault.

Some told me it was just a slap or a push and the girl is being over-dramatic. Some told me the girl doesn't know how to do the household chores. As such things are objectionable to inlaws, so they don't spare. In one way or another, most of the times the girl is blamed.

Keeping her dreams, aspirations, expectations, and respect aside, people expect the

## **ERILS OF NARRATIVE** rrorism **Sa** R P Sa 2 C 2 hroad 6 Correct

ndia is fighting terrorism in Kashmir. One of the forms of terrorism India is fighting is narrative terrorism. Those with blinkers on may deny narrative terrorism. People living in the valley know it as a real and present danger.

#### How Mattoo Practices Narrative Terrorism With Her Camera

Sanna Irshad Mattoo practices narrative terrorism with her camera. Proof – the photographs taken by her, posted on her social media accounts and displayed at the global platforms she can reach.

Mattoo was recently barred by the immigration authorities at New Delhi's Indira Gandhi International Airport from flying to the US despite having a valid visa and ticket. It was the second time in four months that Mattoo was stopped from flying abroad.

Earlier this year, Mattoo had been awarded the Pulitzer for the coverage of Covid-19 pandemic for Reuters. On October 25, Press Club of India (PCI) tweeted that it "failed to comprehend the Government decision" to stop Mattoo from travelling to the United States to receive the Pulitzer Prize.

#### Did PCI Examine Sanna Mattoo's Work?

It seems that the august members of Press Club of India did not see what kind of photojournalism Mattoo is engaging in. While standing up for media freedom, PCI is unaware that Mattoo engages in narrative terrorism. In her photographs, Mattoo projects India as an occupier force in Kashmir. Mattoo keeps reinforcing the stereotype of 'Occupied Kashmir'.

This is done not just by Mattoo. Projecting India as an occupier force in Kashmir is routinely done also by some other so-called journalists and photo-journalists from the Valley.

The narrative posited by Mattoo and others in her league is highly dangerous. It deepens the anti-state sentiment among the radicalized youth of Kashmir. Vulnerable and radicalized youth believe in this propaganda and become militants, hybrid militants or Over Ground Workers (OGWs).

Romanticization of terrorism is among the reasons why a section of Kashmiri boys continue to choose violence and death. These radicalized youth get misled by the dangerous propaganda. They kill innocent people and get killed, leaving their parents wailing and without support in old age.





Swayed by narrative terrorism and other associated factors, militants or hybrid militants kill policemen or Special Police Officers (SPOs) of JK Police. They kill Kashmiri Pandits and they kill non-local labourers who choose to work in Kashmir to make a living.

#### Romanticizing Terrorism In The Name Of Media Freedom

Sanna Mattoo and League romanticize terrorism in the name of media freedom. All these media projections have a deep impact on indoctrinated Kashmiri boys still in their teens.

Terror in Kashmir is handcranked by Pakistan. Sanna Mattoo and Co whitewash the lived reality of terror in Kashmir. The terror inflicted by indoctrinated teenagers or youth is sold as "the resistance of our boys".

For this job, Sanna Mattoo and other so-called journalists

and activists are suitably rewarded with international accolades by agenda-driven global think-tanks. They move in international circuits courtesy their anti-India stance.

On ground level, the sons of poor Kashmiris bear the brunt of this chicanery.

#### Ending Media Duplicity In Kashmir

Regarding the refusal to Sanna Irshad Mattoo to fly out of India, PCI tweeted that Mattoo attending the Pulitzer Prize ceremony would have added to the prestige of the country. "Press Council of India demands that the government should come out clean in this matter," PCI said on its official Twitter handle.

"On the one hand, the government is making all out effort to integrate Kashmir with the national mainstream, on the other such actions only act as deterrents and further aid in alienating people from Kashmir," said the PCI tweet.

The Telegraph wrote on October 25: Ms Mattoo, who was not allowed to travel to the United States of America on an earlier occasion, is entitled to an explanation from the government for its spitefulness.

What is labeled as the government's "spitefulness" is acknowledgement and action on national security, and saving the lives of innocent people.

#### Mr Varghese George Mocks J&K State Investigation Agency (SIA)

Mr George writes:

We have heard of various types of terrorism, and now there is a new one -"narrative terrorism." Or so we are told. The J&K State Investigation Agency (SIA) recently filed a chargesheet in a case of a "narrative terrorism," describing journalist and editor Fahad Shah and scholar Aala Fazili as "contaminated and compromised media persons." According to the SIA, the duo was indulging in "narrative terrorism", as part of a criminal conspiracy to spread terrorism and create a false narrative. "Their (Shah and Fazili) end objective was to create, sustain, and spread disaffection, hatred and enmity against the Indian State. Their interim objective was to preserve Pakistani influence by manipulating and playing with facts, subtly or brazenly, by putting information without context or out of context or selective reporting or selective exaggeration or underplaying or muting others and by craftily and cunningly invoking the legal rights to press freedom and political dissent guaranteed by the very Indian State which they wanted to undermine," the SIA statement said.

#### Holds Forth On State Control

After satirizing the J&K State Investigation Agency (SIA) for taking note of narrative terrorism, Mr George holds forth on state control. He writes: "Controlling the narrative is a critical part of politics – and state control. It is noteworthy here that the SIA is claiming the right to decide what is 'fact'. The battle over narrative is often premised on who decides what is fact and what is not. 'Fact checking' is a new field of journalism, and parallelly the state asserts its right to have the final say on what indeed is fact.

## **CRUCIAL** Controlling The Narrative In War Zone Is Part Of State Control On Security

Mr George rightly states that controlling the narrative is a critical part of politics – and state control. J&K State Investigation Agency is controlling the narrative because once the narrative spins out of control, it's a direct hit on national security. It doesn't impact you or me or Mr George, because we are in our safe cities, protected from the worries that mark Kashmir.

But once the narrative is out of control, the radicalized sons of many poor Kashmiris decide to become militants, hybrid militants or Over Ground Workers for terror groups. Then the narrative of Pakistan rules in Kashmir, and the terror handlers of Pakistan find it easy to recruit indoctrinated youths into their ranks, thrusting upon them one role or another. The role may be to kill a cop, a soldier, an innocent Kashmiri Pandit. Once the narrative is out of control, all this follows.

Then the state is seen as weak for failing to control the situation in Kashmir. Controlling the narrative in war zone is part of state control on security.

People don't come forward and they are not able to benefit from government schemes the way they should.

It is the constant effort of the government to bridge the gap with the people. But this gap does not get filled. In the name of freedom of expression, we have given space to the media to run their own agendas. This negativity makes the youth of Kashmir feel justified in indulging in anti-state behaviour. In extreme cases, they pick up the gun. This impacts national security.

The grassroots public opinion does not get space in the media. The political parties do not really highlight the day-today demands and issues of the people. They run a narrative which is not reflective of public opinion.

Why is public opinion important? When the government gets to know public opinion, it is able to

formulate the policies and welfare initiatives accordingly. These policy decisions impact development initiatives and programs.

Nobody profiles those poor girls – how they were helped. The government has schemes for farmers, for labour. Nobody talks about how farmers and other classes are benefited by government schemes.

Let me share a local example. The DC of Baramulla Dr Syed Sehrish Asgar often goes to the local markets to engage with people, listen to their issues in the evening hours after work. She addresses their problems, resolves them. This is so new for all of us. But the media does not highlight this. They highlight only the negative.
